The American Recovery and Reinvestment Act of 2009 (ARRA) dedicated close to \$800 billion in economic stimulus, with over \$60 billion focused on construction. Like a number of earlier federal acts dealing with publicly funded construction projects, ARRA contains “Buy American” provisions that are preferential to materials manufactured in the United States. However, U.S. trade agreements provide that in a number of circumstances products manufactured in designated countries be given equal treatment with U.S. products, and ARRA like other federal laws also contains waiver provisions that permit the use of materials manufactured in these countries.

Doc’s Industries, Inc. provides fastening products that are manufactured in countries designated under the U.S. trade agreements. Please review the list of products below. Doc’s Industries, Inc. believes you should give serious consideration to fastener quality, and where permitted by law or by available waivers, not substitute lower quality fasteners on the assumption that a choice is not available.
